# No. 3. 24 Page Document

Early 2015, prior to February 17, 2015, Oil Free LLC's research team led by A. Michael Ruggiero who is the Director of Manufacturing for Oil Free LLC and a Laurel, Delaware resident researched the information to print this document. The 24 page document this printing was submitted to Josh Alcorn and the late Beau Biden. # No.5. J.P. Morgan

This letter dated April 27, 2016 is the first letter produced to demonstrate the ability to finance the new U.S. Grid without using any taxpayer dollars. Beau Biden suggested we submit the document in Florida to J. P. Morgan Private Banking due to complex banking problems that as the Attorney General in Delaware he was aware of. He suggested further that we wait at least 60 days from February 17, 2015, the issue date of the 24 page document to see if we receive a written rejection of same and the reason why. A few days prior to April 27, 2015 we had no notification of rejection from anyone in the State of Delaware; he was pleased for us to submit the document to J.P. Morgan as we did by FedEx. ### No. 6. United States Navy

The 4 page letter to the Secretary of the Navy, Ray Mabus, is dated June 8, 2015 and is available by Menu Key selection on the Home Page of our website <a href="https://www.oilfreellc.com">www.oilfreellc.com</a>

The Navy was advised how they could view the Video of the demonstration of the Wallace HOD System producing hydrogen on demand at a minimum rate of 200 liters per minute. The size of the Hydrolyzer system demonstrated will be used primarily for the automotive industry with internal combustion engines of 500 horsepower or less. One gallon of clean fresh water or clean sea water would result in enough hydrogen fuel produced for a vehicle to travel 1,000 miles regardless of location.

Refueling of naval vessels that do not use nuclear energy but fossil fuel like a modern day destroyer must continuously refuel at sea when their supply reaches 50% depletion. That could be anytime, typically every 4-8 days and the process is dangerous and not simple. The destroyer must rendezvous with a larger ship that carries fuel whether it is an "oiler" or an "aircraft carrier" which must function as a floating fuel station. I personally served in the U.S. Navy aboard a Fletcher Class Destroyer June 1958 – June 1960 [The Purdy DD 734]. The exercise of refueling has not changed since that time and is usually considered "all hands on deck" and by no means a cakewalk for the personnel of either ship. GPS technology is now used to assist in speed and course but that was never a significant problem. The biggest downside of refueling at sea is time lost and providing a soft target while completing the process. When the NEW Wallace

HOD System is available for the U.S. Navy our taxpayer dollars will have a Navy with 30% to 40% more coverage and a significant reduction in fuel costs. If the Secretary of the Navy, the Secretary of Defense, the President and Vice President interviewed two (2) Navy Captains, one being from a Destroyer, the other from a refueling ship and the question asked "Would you like to see the refueling process eliminate?" Both would respond yes.

The New Wallace HOD System suitable in size to be used with the Caterpillar CAT G20CM34 10MW now in operation near Ulysses, Kansas could be the same size Hydrolyzer used in Navy vessels at sea. The advantage using the NEW Wallace HOD System on a naval vessel is clearly understood. Using the NEW Wallace HOD System as a fuel supplier for the CAT 20CM34 10MW and that combination to build the New U.S. grid will reduce the cost of electricity to both residential and commercial users by at least 50%.
